

ACI Performance Examinations with CCRL Inspections

When requesting an inspection, you may also request CCRL to conduct an American Concrete Institute (ACI) performance examination for either Aggregate Laboratory Testing Technician Level 1 or Concrete Strength Testing Technician. Please note ACI has restructured some Concrete and Concrete Aggregate Testing Technician Certifications. The combination of an Aggregate Testing Technician Level 1 and Concrete Strength Testing Technician will automatically result in the issuance of a Concrete Laboratory Testing Grade 1 Certification.

The ACI Certification Programs consist of two parts: a performance examination and a written examination. In certain areas a local ACI Sponsoring Group will provide the entire certification program. Before you decide to take the performance examination portion with CCRL, it is your responsibility to contact ACI to determine when and where the written examination will be available to you locally and what arrangements you must make to complete the process.

Since the inspection procedure review is used to offset the cost of the examination, two fees are available for the performance examination for the Aggregate Laboratory Testing Technician Level 1 depending upon the inspection requested:

Laboratories whose inspection request includes a concrete aggregate inspection will be charged \$350 for each technician taking the ACI performance examination for Aggregate Laboratory Testing Technician Level 1.

Laboratories whose inspection request does not include a concrete aggregate inspection will be charged \$410 for each technician taking the ACI performance examination for Aggregate Laboratory Testing Technician Level 1.

The cost for the performance examination of the Concrete Strength Testing Technician Program is \$230 for each technician and your inspection request must include a concrete inspection.

- The cost(s) of the performance examinations are payable to CCRL. Fees for the written examination or other ACI charges are not included.
- Technicians to be tested must be employees of the testing laboratory receiving the standard CCRL Inspection.
- **Due to time constraints of scheduling inspections, only the number of technicians requested on this form can be tested during the inspection.**
- **Technicians not passing the performance examination cannot be retested by the CCRL until the next tour.**
- **Arrangements will be made by ACI to accommodate a retest.**
