

Projected Schedule of Inspections

The table below shows the tentative schedule plans of CCRL based on inspections as of 11/15/2024. Modification to this schedule may be necessary if additional requests are received. **CCRL e-mails enrollment information approximately 4 months prior to entering a state.** The inspection tour is still experiencing delays due to effects from the pandemic.

In addition to areas mentioned in the table, CCRL is also inspecting laboratories in the local area of Maryland, Northern Virginia, Delaware, Eastern West Virginia, and Southern Pennsylvania on a continuous basis.
